HANDELSTERME

1. Goedere moet met kontant, kredietkaart of EFT betaal word.
2. Die handtekening van die koper, sy/haar werknemer of agent op die verkoper se afleweringssnota of faktuur is afdoende bewys van ontvangs van goedere.
3. Daar word geag dat aflewering plaasgevind het by die verkoper se perseel of wanneer goedere oorhandig is aan die karweier wat geag word die koper se agent te wees.
4. Ondanks aflewering, of die toestaan van krediet, bly die verkoper die eienaar van alle goedere wat verkoop is, totdat ten volle daarvoor betaal is en die verkoper mag die goedere terugneem.
5. Inligting op die verkoper se dokumente, asook enige advies, aanbeveling of hulp deur 'n werknemer of agent van die verkoper, word te goedertrou sonder enige verpligtinge of waarborg gegee.
6. Die koper stem toe tot die jurisdiksie van die Landroshof, maar die verkoper mag in die Hooggereghof voortgaan.
7. Rente teen 2% per maand word vanaf datum van verskuldiging op die uitstaande bedrag bereken.
8. Die koper onderneem om alle prokureur- en kliëntkostes te betaal.

TRADING TERMS

1. The goods must be paid with cash, credit card or EFT.
2. Signature of the purchaser, his/her employee or agent on the seller's delivery note or invoice shall be conclusive proof of receipt of goods.
3. Delivery shall be deemed to have taken place at the seller's premises or upon the goods being handed over to the carrier who shall be deemed to be the purchaser's agent.
4. Notwithstanding delivery or the granting of credit, the seller will remain the owner of all goods sold until the goods have been paid for in full and the seller may repossess the goods.
5. Information on the seller's documents, or any advice, recommendation or assistance by an employee or agent of the seller, is given in good faith but without any obligation or warranty.
6. The purchaser consents to the jurisdiction of the Magistrate's Court, but the seller may proceed in the Supreme Court.
7. Interest on the outstanding balance shall accrue at 2% per month, calculated from due date.
8. The purchaser undertake to pay all attorney and client costs incurred by the seller.
9. These trading terms are in addition to the seller's common law rights.
10. The purchaser chooses his/her street or email address as domicilium citandi et executandi.
